Vision

Our vision is to partner with homeschool families in equipping tomorrow's leaders by fostering an environment where children can discover their God-given gifts and talents so they can fulfill their calling and leave a legacy for future generations.

Mission

Our mission is to support and encourage homeschool families in their goals for their individual children by providing a place of community where families can resource out learning for the unique needs of their children based on ability and not age in order to grow and develop their child's God given gifts, talents, and leadership skills.

Purpose

The Legacy Alliance exists to minister to the needs of K-12 homeschool families based upon God's principles and truth. Our ministry encourages families who have taken responsibility for their children's education and provides community, activities, and events that support them in their homeschool journey. We offer various one, two, and four hour complementary core and enrichment classes, a la carte classes, one to four days a week at Meadowlark Community Church. Families can individually pick classes that meet their specific needs. While we try to meet the needs of our community, we do not exist to provide an academy or a private school program. Our goal is to assist the homeschool community and not provide a full educational experience.

Our Role

Legacy's Commitment

Membership with The Legacy Alliance includes access to our community of vendors and homeschoolers. We aim to meet the needs of our community so long as those needs are in alignment with our vision, mission, purpose, and core values. We make ourselves available to you in order to walk alongside you and encourage you in your homeschool journey.

Legacy's Services

We provide a community offering core and enrichment courses, homeschool support, on and off campus activities and events, clubs, field trips, a newsletter, a members only website with access to class resources and communications.

Our events include Makers Markets, a Father-Daughter Dance, Mother-Son Night Out, field trips, fundraisers, outreaches and holiday events to name a few. At Legacy, we like to stay connected, so our activities on and off campus occur year round. We are more than just alternative education, we are a community that cares.

Our unique model is a ministry to the homeschool community that offers exceptional classes for K-12 homeschool students. We offer a-la-carte core classes and enrichment courses that aim to enhance, support, and supplement all homeschool curriculums. Classes are taught by diverse and dynamic vendors who have years of experience in their chosen field and a genuine passion for inspiring students to become curious and enthusiastic lifelong learners. We believe parents know their children best and our model allows families to create their own schedule to meet their child's individual learning needs. We also support our families with consulting services to assist in selecting curriculum and obtaining additional resources for their at home education.

Family Role

Parent Participation Commitment

You are an essential part of your children's education and the Legacy community. All of our parents must commit to participating and serving on campus, in order for our community to operate. This also develops community and friendships with other homeschool families. There are six primary onsite shifts for parents to participate in which are: Campus Setup and Teardown, Study Hall, Front Desk, Hallway Monitor, and Lunch Monitor.

Each member, or family, commits to serve a minimum of 12 hours per semester, per track (M/W or T/TH), or 18 hours if attending both tracks. More detailed instruction can be found under each role description on the website ([CLICK HERE](#)). Be sure to sign into your account and then search for the "Parent Participation Commitment" graphic on the left side. Once there, click on the track you are attending. All shifts and descriptions can be found there. Additional instruction will be given on how to perform campus setup and teardown for each shift.

Please note that to maintain your membership you must fully sign up for and complete your required parent-participation shifts before enrolling in classes. Arriving 15 minutes late (or more) to a shift will require you to make up that time with an additional shift of equal length. If you miss a shift without covering it, you must schedule two replacement shifts: one to cover the missed hours and a second shift of the same duration. Failure to fulfill these requirements may result in removal from the program and cancellation of your membership.

Once all primary onsite parent participation shifts have been filled for the semester there will be additional opportunities to help make the Legacy experience unforgettable for members and their children. Some of the additional opportunities include, but are not limited to: teaching (depending on your expertise and room availability), hosting a club, running a special event, producing the Legacy yearbook, and overseeing field trips.

It's our goal to maintain a culture where our students always feel seen, loved and comfortable. When you serve, we ask that you treat all children as family, so that they feel cared for and free to learn from mistakes. While you serve, you are the eyes and ears of Legacy. You get to help deepen our culture by ensuring that bullying or negative speech stays out of our community and help to maintain a culture of kindness and respect for each other. You will be empowered to kindly, but firmly correct any students and have them reconcile with their peers. Your love will encourage them to show love and give grace by leading as an example. If there are behavioral issues beyond your abilities, you can always come to a member of leadership at any time to support you. *"A new commandment I give to you, that you love one another; as I have loved you, that you also love one another. By this all will know that you are My disciples..." (John 13:34-35)*

Parent & Vendor Relationship

Legacy's mission is to support and encourage homeschool families. One of the benefits of this community is the partnership between parents and vendors to equip your child. Our hope is that you build a relationship with the vendors as they come alongside your family. We ask that your communications are respectful and professional. Any class questions will need to be directed to the individual vendor.

Each class that a family chooses to participate in is run and operated by educational vendors. Each vendor is their own business. Families will pay each educational vendor directly for the "class" their child is participating in. The vendor in turn pays Legacy to lease the space. If there is ever an issue with a vendor that you cannot agree upon, please notify Legacy staff so we can all work to reconcile the question at hand. Vendors will notify Legacy of late or missed payments by families. Legacy reserves the right to cancel membership for late or missed payments.

Charter Agreement

If you are homeschooling privately, you can disregard this agreement.

If you are homeschooling through a public charter school, it's important to understand that The Legacy operates independently and has no formal relationship with any charter school. While some of the teachers who offer classes at The Legacy may also be approved vendors with your charter, The Legacy itself is not a vendor and should not be listed as one.

If you wish to use charter funds for a class, you must communicate directly with your charter school. Be sure to refer to the specific course title and the teacher's name—not The Legacy or The Legacy Homeschool Alliance—as your charter will not recognize our organization.

As long as you understand this distinction, using charter funds should be a smooth process.

Please remember: The Legacy is not a school and is not affiliated with any charter. We are a membership-based program that provides a central location and community where independent vendors can offer their services to homeschool families.

Payment

Membership Fee

The only payments made directly to The Legacy are the semester-based membership (or registration) fee and any fees for Legacy-operated study hall or lunch hours. These cover operational expenses and help support community activities.

Please note that we are not a vendor with any charter schools and do not accept instructional funds. All payments to The Legacy must be made out of pocket.

Course Fees and Scholarship Fund

Legacy's mission is to support and encourage homeschool families. One of the benefits of this community is the partnership between parents and vendors to equip your child. Our hope is that you build a relationship with the vendors as they come alongside your family. We ask that your communications are respectful and professional. Any class questions will need to be directed to the individual vendor.

Whatever courses you enroll in, you will be responsible to pay the vendor directly. Their payment information is listed under their course description. If they are a vendor with a charter that you are enrolled with, you can inquire with your charter about using the funds they give you to pay for that vendor's class, however paying through your charter is between you, your charter, and the vendor; Legacy is not involved.

Each class that a family chooses to participate in is run and operated independently by educational vendors. They are very accommodating, and offer monthly payment plans through PayPal, Venmo, charter funds, or other convenient payment systems. Vendors will notify Legacy of late or missed payments by families. Legacy reserves the right to cancel membership for late or missed payments.

We want to make Legacy accessible to all families. If your family is experiencing financial hardship, we have a scholarship fund. Details can be found under the member resource drop down tab on the Legacy homepage or [click here](#).

Behavioral Agreement

Discipline

The goal of Legacy's ministry is to steward the hearts of God's children while attending excellent homeschool enrichment courses. Our policy is that the parent is the best person to manage their children and their behavior. However, if a child's behavior is disruptive/harmful to other children, facilities, or vendors during their day, Legacy will address the situation as follows:

- Verbal Warning: Students will receive a verbal warning. Directors or vendors will encourage reconciliation and/or encourage better future choices, if necessary.
- Sent to Administrator: If continued behavior outside of the Legacy Code of Conduct occurs, the student will be sent to the Administrators, and not participate in the remainder of the course period. Parents will be called and made aware of the situation.

- Parent Pick-up: If the student continues to exhibit behavior outside of the Legacy Code of Conduct, the parent will be required to pick up their student for the remainder of the day.
- Parent Classroom Requirement: If a student has been removed for the day, the student's parent/s will be required to accompany them back to Legacy the next time they are on campus, to manage their child's behavior.

Legacy reserves the right to terminate membership of any student or family not in support of our Code of Conduct agreement and/or if repeated offenses by the student occur without change or resolution.

Respect for the Church and Facilities

Legacy students, families and vendors are expected to treat the Meadowlark Campus with respect. We are thankful to Meadowlark Church for partnering with us by renting us space. While things can happen that are out of our control, it is important to understand that any damages or vandalism caused by your child/ren will ultimately be your responsibility as a parent/guardian to rectify.

We will implore the disciplinary structure as outlined above and a parent/guardian will be involved in the implementation of restoration of property/financial reconciliation to ensure that Legacy is upholding its rental agreement and partnership with Meadowlark Church. It is our wish to be invited to renew our lease here year after year, so it is important to Legacy that the property is treated with respect, love and gratitude by all.

Weapons and Threats of Violence:

Legacy is committed to providing a safe educational environment for students, staff, vendors and visitors on campus. Therefore, the possession of weapons and any threats of violence are strictly prohibited.

A weapon is defined as: any object designed to inflict harm.

A threat of violence is defined as: any verbal, written, or physical expression that implies intent to cause harm to individuals or property.

All incidents or suspicions of weapons on campus or threats of violence must be reported immediately to a school staff member.

Consequences: Violation of this policy will result in disciplinary action, up to and including suspension or expulsion, and may involve law enforcement as deemed necessary.

Policies & Procedures

Identification Policy

Safety is vital to us, which is why Legacy hand selected this location. The Meadowlark campus is located on its own property, far from public view and access. All individuals on the Meadowlark campus must check in at the front desk. The only adults allowed on campus during operational hours will be Meadowlark Church staff, Legacy staff, Legacy vendors, and families of Legacy attendees. Families are required to wear a Legacy photo ID badge and individuals with the church will have different colored name badges to make them clearly distinguishable. The front desk monitors will be checking badges during drop off and pick up. If someone other than the parent is dropping off or picking up a child, this person will need to show the parent's badge. Only one badge is required per family. Vendors are required to wear their photo ID badge while on campus. Any campus visitors will need to first check in with the front desk monitor and will be required to wear a visitor badge while on campus. You can purchase your photo [ID badge here](#)

Children, TK-3rd, will be required to wear a lanyard while on campus at all times with their course schedule attached to it. You can find the schedule template to print out on our website [here](#). Please print it, fill out your TK-3rd graders schedule, and place it in the clear schedule holder. You can purchase the lanyard and holder at orientation or by visiting our front desk.

Electronics policy

We allow electronics on campus, under adult supervision, for the following reasons:

- 1) Parent Communication: A phone or device necessary for contacting parents and/or guardians. Devices need to be kept in backpacks at all times. If a child would like to use the device, they first need to find an adult to supervise them while they quickly use the device to communicate with a parent or guardian only. No devices are allowed in bathrooms or private places.
- 2) Educational Purposes: A computer or ipad may be needed for homework during study hall or for a class requiring it. In class, the vendor will be responsible for monitoring screen activity. Study hall monitors will supervise devices used for educational purposes only. Screens need to be facing the supervising adult at all times. Outside of these guidelines, we will have zero tolerance for cell phone/electronics use.

Electronic devices are only allowed to be used under adult supervision. No devices are allowed on the playground or during lunch. We reserve the right to confiscate any electronic devices not being used per our policy and to dismiss any member without a refund who refuses to adhere to the aforementioned policy. Parents will be notified at pick-up, and only a parent may retrieve the device.

Sick Policy

If your child is ill, please keep them home. If a child has a fever, green mucus, a persistent cough or runny nose, stomach ache, stomach flu (vomit) or diarrhea; we will ask the parent to pick them up immediately. Please make sure that your child is free of all symptoms and fever for a minimum of 24 hours before returning to campus.

Lice Policy

Please notify the Campus Director immediately if your child has lice so that we can notify our members. The quicker lice can be identified, the easier it is to manage. Please keep your child home if they have lice. Vendors will be notified so that families can be contacted letting them know their child might have had exposure to lice and to inspect their children. After the second application or official recheck of the lice treatment, the child can return to the program. The identity of the infected child will not be shared.

Dress Code

When attending Legacy, on or off campus events and programs, please ensure your attire is modest and appropriate.

- Shorts, skirts, and dresses must be long enough that they reach the same point on the thigh as the bottom of a student's closed fist when the arm is extended and resting on the thigh.
- Clothing that is revealing or immodest, or tops that expose bare midriff or undergarments are not allowed. Necklines must be modest and not expose cleavage or too much of the chest. All parts of the stomach and back must be fully covered without pulling or tugging. Examples of what not to wear include, sports bras, tube tops, crop tops and low cut tops.
- Clothing that displays derogatory language, pictures or suggestive messages are not allowed.

If a student is found to be in violation of the dress code, a (Legacy-issued) loaner article of clothing will be provided in order for the student to continue to attend classes and program activities.

We reserve the right to send children home who are dressed in inappropriate or distracting clothing. Thank you for partnering with us to create a positive environment for our children.

Special Needs/Allergy Policy

Please contact the Executive Director if you have a child that has special medical or behavioral needs that require special accommodation. Legacy seeks to meet the needs of all families and will do its best to accommodate all members. Legacy asks all vendors to not use any peanut products in their classes, but we cannot control what children bring inside their lunches. If your

child has life threatening peanut allergies, please educate them or supervise them during lunch hour, as well as tie a bright ribbon to their backpack where their epipen is kept so staff and vendors are aware.

Lunch, Study Hall, and Vendor Assistant Policy

Lunch and Study Hall are Legacy supervised periods. A small fee covers the space and costs associated with meeting the needs during these times. If your student attends Lunch or Study Hall they will need to be enrolled prior to attending.

*Study hall is for 2nd-12th grade and is limited to one period per day (with the exception of highschoolers). Please make sure that any student attending study hall has an hour's worth of work and assignments to complete. There will be study hall monitors that are able to assist groups of students. Students who are asked more than once to stay homework-focused will be asked to drop study hall and enroll in a class.

If your 6th-12th grade child would like to step into a leadership role, they can enroll as a Vendor Assistant (maximum one position per day). There is no cost to enroll as a Vendor Assistant. **You will need to contact the vendor for approval before enrolling online.** If you need volunteer hours signed off on, or a letter of recommendation, you can ask your vendor if they can provide this for you.

Food/Water on Campus

Please be sure to bring a refillable water bottle while on campus. Water bottles are available for one dollar each in our café for children who forget their water. If you are enrolled in lunch, please bring a packed lunch and/or money for the café with you. Your child is able to eat between periods and during lunch. It is their responsibility to throw away all trash and to clean up any crumbs they spill. Please make sure your child understands this policy and our desire to leave the facility better than we found it.

Off Campus Events

While the heart of Legacy is to foster community, we are not responsible for any events attended off campus and are free from all liability. Attending an event off campus is each family's choice and all liability falls under them. It is each family's responsibility to supervise their children at all times at off campus events.

Program Details

Check-in & out

Drop off begins no earlier than 8:15am and pick up ends no later than 3:10pm. The Legacy program begins at 8:30 am and ends at 3pm. We ask that you please leave the classrooms immediately following pick up so that we can clean them and the rest of the campus in a timely and efficient manner. All vendors and families need to be off campus by 4:00pm unless otherwise specified.

Late Fee Pick-up Policy

To maintain a safe and respectful environment for all students and staff, the following late pick-up fees will be enforced. Legacy offers a 15-minute grace period after your child's last class for parent pick-up.

- Pick-ups made **after the 15-minute grace period** will incur a **\$25 late fee**.
- If pick-up is **more than 30 minutes past the grace period**, the **late fee increases to \$50**.

** An invoice will be added to your Legacy account. Continued late pick up will result in further action**

Thank you for helping us ensure a smooth and safe dismissal process.

Chapel (Optional)

Part of the ministry of Legacy is daily chapel gatherings. Attendees and families are welcome to join but participation is not mandatory, and does not affect membership. Every morning at 8:30am before classes start, we will meet for Chapel. Families and vendors are welcome to join us. This time is 10-15 minutes long and will include morning announcements, honoring our country with the pledge of allegiance, and a time for prayer. All unsupervised children on

campus during chapel are required to attend. If it is your wish to not attend, it is your responsibility to drop your student off at the start of class. If your child is not enrolled in a first period class, you are still welcome to participate in Chapel.

Weekly Communication

Legacy will send out a bi-weekly newsletter to our members with information on upcoming activities and events. Any communication automated from our website can be changed by the user in settings once they are logged into the website. Information from our bi-weekly newsletter will be available on our website after it is sent, under the resources tab.

Clubs

If you would like to start a club, please contact a Legacy Administrator for more information. Members are welcome to attend as many clubs as they desire. Some possible clubs include Hiking Club, Surf Club, Prayer Club, Morning for Moms, Book Club, and Chess Club.

We’re also looking for parents who would like to join our **Legacy Leaders Event Team**—a group of faith-filled, talented individuals who come together to serve and strengthen our Legacy community. Main events include but are not limited to the Christmas Maker’s Market, Father Daughter Dance, Legacy Community Fair, Mother Son Night Out. Legacy holds no liability for off campus events.
