**Y- Youth** - Let no one despise you for your youth, but set the believers example...We are equipping tomorrow's leaders for today.



# Membership Agreement

## Our Role

### Legacy's Commitment

Membership with The Legacy Alliance includes access to our community of vendors and homeschoolers. We aim to meet the needs of our community so long as those needs are in alignment with our vision and mission. We make ourselves available to you in order to walk alongside you and encourage you in your homeschool journey.

### Legacy's Services

We provide community, homeschool support, core and enrichment classes, on and off campus activities and events, clubs, field trips, a newsletter, a members only website with access to class resources and communications.

Our events include Makers Markets, a Father-Daughter Dance, Mother-Son Night Out, Forest Home Family Camp, field trips, fundraisers, outreaches and holiday events to name a few. At Legacy, we like to stay connected, so our activities on and off campus occur year round. We are more than just alternative education, we are a community that cares.

Our unique model is a ministry to the homeschool community that offers exceptional classes for K-12 homeschool students. We offer a-la-carte core classes and enrichment courses that aim to enhance, support, and supplement all homeschool curriculums. Classes are taught by diverse and dynamic vendors who have years of experience in their chosen field and a genuine passion for inspiring students to become curious and enthusiastic lifelong learners. We believe parents know their children best and our model allows families to create their own schedule to meet their child's individual learning needs. We also support our families with consulting services to assist in selecting curriculum and obtaining additional resources for their at home education.

## Vendor Role

### Vendor Commitment

Being a vendor with us means you are a teacher or educational vendor operating your own business and willing to offer your services to our unique community in alignment with our values and vision. You will be responsible for collecting payment from families enrolled in your classes.

If you are with a charter school, you will need to continue to meet the charter requirements which include allowing students in your classroom that are not in our program. Legacy is in agreement with this requirement, however, you will need to make sure parents pick up and drop off solely for your class if they are not members of our program as well.

While Legacy students are in your class, they are your responsibility, however, please send them to our Campus Director if they are distracting from your class and we will make sure to contact the parents.

## Family Role

### Parent Participation Commitment

All of our parents must commit to participating and serving at Legacy in order for our community to operate. There are four primary onsite shifts for parents to participate in which are: Study Hall, Front Desk, Hallway Monitor, and Lunch Monitor. In Study Hall, parents oversee students as they work on various tasks from classes. Parents serving at the Front Desk are responsible for welcoming families, having them sign in and out for the day, and directing students where to go to find their classrooms. The Hallway monitor helps students find their classes, check absences, and assists in other activities around campus. Parents serving as Lunch Monitors supervise children during lunch, addressing any disputes that may arise, and encourage life-giving speech. Campus Setup and Campus Teardown Each member, or family, commits to serve a minimum of 12 hours per semester, per track (M/W or T/TH), or 24 hours if attending both tracks. More detailed instruction can be found under each role description on the website ([CLICK HERE](#)). Be sure to sign into your account and then search for the “Parent Participation Commitment” tab with the “We Believe In Making A Difference” graphic. Once there, click on the track you are attending. All shifts and descriptions can be found there. Additional instruction will be given on how to perform campus setup and teardown for each shift. Please remember, if you do not completely sign up and fulfill your parent participation commitment, you will be dropped from our program and your membership will be canceled. All members must register for their parent participation shifts prior to enrolling for classes. If a family joins Legacy mid semester, they must register for parent participation shifts within 10 business days. When a parent participation shift is missed and the family does not cover the shift, the family will have to sign up for another shift to make up the missed shift (with the same number of hours), plus the family is required to sign up for an additional shift (with the same number of hours as the missed shift), and finally a \$40 per hour fee per hour of the missed shift will be added to your account. Once all primary onsite parent participation shifts have been filled for the semester there will be additional opportunities to help make the Legacy experience unforgettable for members and their children. Some of the additional opportunities include, but are not limited to: teaching (depending on your expertise and room availability), tutoring students, hosting a club, running a special event, producing the Legacy yearbook, assisting in our garden/farm, supervising on campus, and overseeing field trips.

It's our goal to maintain a culture where our students always feel seen, loved and comfortable. When you serve, we ask that you treat all children as family, so that they feel cared for and free to learn from mistakes. While you serve you are the eyes and ears of Legacy. You get to help deepen our culture by ensuring that bullying or negative speech stays out of our community and help to maintain a culture of kindness and respect for each other. You will be empowered to kindly, but firmly correct any students and have them reconcile with their peers. Your love will encourage them to show love and give grace by leading as an example. If there are behavioral issues beyond your abilities, you can always come to our Campus Director at any time to support you.

## **Parent & Vendor Relationship**

Each class a family chooses is run and operated by a teacher or educational vendor who is their own business. Any class questions will need to be directed to them. Families pay the vendor directly for whatever classes they enroll in. The vendor in turn pays Legacy to lease the space. Parents & Vendors work in partnership to help grow and develop the child. Please build your relationship and communicate well with each other. If there is an issue you cannot reach an agreement on, please notify Legacy staff. Vendors will notify Legacy of late or missed payments by families. Legacy reserves the right to cancel membership for late or missed payments.

## **Payment**

### **Membership Fee**

The only monies Legacy collects from you is our membership fee (or registration fee) paid per semester and tuition for any Legacy operated class/period like study hall or lunch. These fees cover some operational costs and go towards community activities. We are not a vendor with any charter schools and do not accept instructional funds through them. You will need to pay for our program out of pocket.

### **Class Fees**

Whatever classes you enroll in, you will be responsible to pay the vendor/teacher for. Their payment information is listed under their course description. If they are a vendor with a charter that you are enrolled with, you can inquire with your charter about using the funds they give you to pay for that vendor's class, however paying through your charter is between you, your charter, and the vendor; Legacy is not involved.

At Legacy we have a culture of honor and as such hope that all families will honor their financial commitments in a timely manner. Our vendors are amazing, very accommodating, and usually offer monthly payment plans through PayPal, Venmo, charter funds, or other convenient payment systems.

# Behavioral Agreement

## **Discipline**

We believe it is the family's responsibility to address the needs of their children. However, if a child's behavior is disruptive/harmful to other students, classroom, or vendor during their day at Legacy, Legacy reserves the right to address the behaviors in alignment with our core values. This includes but is not limited to addressing the inappropriate behavior/action, asking for forgiveness, developing a plan for reconciliation, and encouraging better future choices.

The parent/guardian will be contacted immediately in regards to the disciplinary action. Legacy reserves the right to terminate membership of any student or family not in support of these behaviors, or if repeated offense by the same student occurs without change/resolution.

## **Respect for the Church and Facilities**

Legacy students, families and vendors are expected to treat the Meadowlark Campus with respect. We are thankful to Meadowlark Church for partnering with us by renting us space. While things can happen that are out of our control, it is important to understand that any damages or vandalism caused by your student(s) will ultimately be your responsibility as a parent/guardian to rectify.

We will implore the disciplinary structure as outlined above and a parent/guardian will be involved in the implementation of restoration of property/financial reconciliation to ensure that Legacy is upholding its rental agreement and partnership with Meadowlark Church. It is our wish to be invited to renew our lease here year after year, so it is important to Legacy that the property is treated with respect, love and gratitude by all.

# Policies & Procedures

## **Identification Policy**

Safety is vital to us, which is why Legacy hand selected this location. The Meadowlark campus is located on its own property, far from public view and access. It is equipped with 24/7 video surveillance on all areas of the parking lot and campus. The only people allowed on the property are with Legacy or the church, but all individuals must go through security first. With that in mind, we require all adult members to show identification while on campus. Parents are required to wear a Legacy photo ID badge and individuals with the church will have different colored name badges to make them clearly distinguishable. The front desk monitors will be checking badges during student drop off and pick up. If someone other than the parent is dropping off or picking up a child, this person will need to show the parent's badge. Only one badge is required

per family. Vendors are required to wear their photo ID badge while on campus. Any campus visitors will need to first check in with the front desk monitor and will be required to wear a visitor badge while on campus. You can purchase your photo ID badge [here](#)

**Children grades K-3rd will be required to wear a lanyard while on campus at all times** with their course schedule attached to it. You can find the schedule template to print out on our website. Please print it, fill out your K-3rd graders schedule, and place it in the clear schedule holder. You can purchase the lanyard and holder by going to resources on our website.

## **Electronics policy**

We allow electronics on campus, under adult supervision, for the following reasons:

- 1) Parent Communication: A phone or device necessary for contacting parents and/or guardians. Devices need to be kept in backpacks at all times. If a child would like to use the device, they first need to find an adult to supervise them while they quickly use the device to communicate with a parent or guardian only. No devices are allowed in bathrooms or private places.
- 2) Educational Purposes: A computer or ipad may be needed for homework during study hall or for a class requiring it. In class the vendor will be responsible for monitoring screen activity. Study hall monitors will supervise devices used for educational purposes only. Screens need to be facing the supervising adult at all times.

**Electronic devices are only allowed to be used under adult supervision.** No devices are allowed on the playground or during lunch. We reserve the right to confiscate any electronic devices not being used per our policy and to dismiss any member without a refund who refuses to adhere to the aforementioned policy.

## **Sick Policy**

If your child is ill, please keep them home. If a child has a fever, green mucus, a persistent cough or runny nose, stomach ache, stomach flu or diarrhea; we will ask the parent to pick them up immediately. Please make sure that your child is free of all symptoms and fever for a minimum of 24 hours before returning to campus.

## **Lice Policy**

Please notify the Campus Director immediately if your child has lice so that we can notify our members. The quicker lice can be identified, the easier it is to manage. Please keep your child home if they have lice. Vendors will be notified so that families can be contacted letting them know their child might have had exposure to lice and to inspect their children. After the second application or official recheck of the lice treatment, the child can return to the program. The identity of the infected child will not be shared.



## Dress Code

When attending Legacy, on or off campus events and programs, please ensure your attire is modest and appropriate.

- Shorts, skirts, and dresses must be long enough that they reach the same point on the thigh as the bottom of a student's closed fist when the arm is extended and resting on the thigh.
- Clothing that is revealing or immodest, or tops that expose bare midriff or undergarments are not allowed. Necklines must be modest and not expose cleavage or too much of the chest. All parts of the stomach and back must be fully covered without pulling or tugging. Examples of what not to wear include, sports bras, tube tops, crop tops and low cut tops.
- Clothing that displays derogatory language, pictures or suggestive messages.

If a student is found to be in violation of the dress code, a (school-issued) loaner article of clothing will be provided in order for the student to continue to attend classes and school activities.

We reserve the right to send children home who are dressed in inappropriate or distracting clothing. Thank you for partnering with us to create a positive environment for our students.

## Special Needs/Allergy Policy

Please contact the Executive Director if you have a child that has special medical or behavioral needs that require special accommodation. Legacy seeks to meet the needs of all families and will do its best to accommodate all students. Legacy asks all vendors to not use any peanut products in their classes, but we cannot control what students bring inside their lunches. If your child has life threatening peanut allergies, please educate them or supervise them during lunch hour, as well as tie a bright ribbon to their backpack where their epipen is kept so staff and vendors are aware.

## Lunch, Study Hall, and Teacher Assistant Policy

Lunch and Study Hall are Legacy supervised periods. A small fee covers the space and costs associated with meeting the needs during these times. If your student attends Lunch or Study Hall they will need to be enrolled prior to attending.

\*Study hall is limited to one period per day, with the exception of highschoolers, and *does not accommodate Kindergarteners*. Please make sure that any student attending study hall has an hour's worth of work and assignments to complete. There will be study hall monitors that are able to assist groups of students.

If your child would like to step into a leadership role, they can enroll as a Teacher Assistant. There is no cost to enroll as a Teacher Assistant. **You will need to contact the teacher for**

**approval before enrolling online.** You cannot enroll in more than one Teacher Assistant position per day with the exemption of highschoolers. If you need volunteer hours signed off on, or a letter of recommendation, you can ask your teacher if they can provide this for you.

## **Food/Water on Campus**

Please be sure to bring a refillable water bottle while on campus. If you are enrolled in lunch, please bring a packed lunch with you. Your child is able to eat between periods, before & after classes, and during lunch. It is their responsibility to throw away all trash and to clean up any crumbs they spill. They may not eat in carpeted areas. Please make sure your child understands this policy and our desire to leave the facility better than we found it.

## **Off Campus Events**

The Legacy Alliance is not responsible for any events attended off campus and is free from all liability. Attending an event off campus is the families' choice and all liability falls under them. It is the families' responsibility to supervise their children at all times at off campus events.

# **Program Details**

## **Check-in & out**

Drop off begins no earlier than 8:15am and pick up ends no later than 3:10pm. The Legacy program begins at 8:30 am and ends at 3pm. We ask that you please leave the classrooms immediately following pick up so that we can clean them and the rest of the campus in a timely and efficient manner. All vendors and families need to be off campus by 4:00pm unless otherwise specified.

## **Program Times**

Vendors Arrival: 7:30-8:15 (*VENDORS: Please be in rooms no later than 15 minutes before class time begins as students will be arriving then and you will be responsible for their supervision*)

Student Drop Off: 8:15am-8:30am

Morning Gathering: 8:30am to 8:40am

1st Period - 8:45am to 9:45am

2nd Period - 9:55am to 10:55am

3rd Period - 11:05am to 12:05pm

Lunch - 12:05pm to 12:45pm (3 whistles will be blown at 12:40pm allowing students to clean up, get water and go to the restroom before class begins at 12:50pm)

4th Period - 12:50pm to 1:50pm

5th Period - 2:00pm to 3:00pm

## **Vendor Usage**

Vendors are able to begin setting up at 7:30am and must be out of their classrooms by 3:30pm. **Vendors are responsible for setting up, cleaning and returning their classroom to its original condition.** This includes setting up tables and chairs, vacuuming, taking out the trash, wiping down tables and chairs, and always keeping in mind that we want to leave it better than how we found it. Again, please be in your rooms no later than 15 minutes before class begins.

## **Morning Gathering (Optional)**

Every morning at 8:30am before classes start, we will meet for Morning Gathering. Families and vendors are welcome to join us. This time is 10-15 minutes long and will include morning announcements, honoring our country with the pledge of allegiance and a time for prayer. All students on campus during morning gathering are required to attend. If it is your wish they do not attend, it is your responsibility to not drop them off until the start of classes. If your child is not enrolled in a first period class, you are still welcome to participate in Morning Gathering.

## **Weekly Communication**

Legacy will send out a bi-weekly newsletter to our members with information on upcoming activities and events. Any communication automated from our website can be changed by the user in settings once they are logged into the website. Information from our bi-weekly newsletter will be available on our website after it is sent.

## **Clubs**

Leading a club fulfills the Parent Participation Commitment required per semester. Members are welcome to attend as many clubs as they desire. ## ADULT WAIVER AND RELEASE OF LIABILITY
